# Top of the Charts: New York and Its Localities Were #1 in Taxes and #2 in Spending



#### NY State and Local Taxes & Spending Are Higher than Almost Every Other State

- New York State and its localities spent **50 percent more** per capita than the national average in 2021—higher than all other States except Alaska
  - Higher than CA (7%), MA (24%), NJ (55%), TX (71%), FL (101%)
- New York State and its localities *led in taxes*, collecting the most per person (63% more than the national average) and the most per \$1,000 personal income (36% more than the national average)
- New York State and its localities collected *more revenue from all types of taxes*—property, personal income, corporate, and sales—than most other States and their localities
- Notes:
  - The following slides compare tax collections and spending by New York State and its localities to regional and national competitors—California, Connecticut, Florida, Massachusetts, New Jersey, Pennsylvania, and Texas—and the top 10 taxing and spending states in each category
  - Data are from the U.S. Census Bureau's Annual Survey of State and Local Government Finances, 2021, the latest year available.
  - Since fiscal year 2021, NYS increased the personal income tax rate, instituted a business tax surcharge, and authorized a tax
     increase for the Metropolitan Transportation Authority. Both New York City and State have also increased spending significantly.

#### Total State & Local Expenditure per Capita, Top 10 & Comparator States, 2021









## NYS and Localities Collected More Personal Income Tax per \$1,000 of Income than 48 States









#### **Data Sources and Methodology**

#### **Data Sources**

- U.S. Census Bureau Annual Survey of State and Local Government Finances, 2021
  - State self-reported revenue and expenditure data, using Census Bureau <u>guidance</u> and <u>classification manuals</u> 2021 data are for individual government fiscal years that ended between July 1, 2020 and June 30, 2021
- U.S. Bureau of Economic Analysis (BEA) Data by State
  - State personal income data, from SAINC1, for calendar year 2021
  - State gross domestic product (GDP), from SAGDP1, for calendar year 2021
- U.S. Census Bureau National Population Estimates by Region for 2021

#### Methodology

- Total expenditures exclude long-term debt liabilities and insurance trusts but include utility spending on transit systems
- Total revenues exclude revenues from utilities (expect transit fares and tolls), insurance trusts, other minimal fine and fee revenue areas (not taxes) due to irregularity of coding across states
- Revenues and expenditures of multi-state entities, such as the Port Authority of New York and New Jersey (PANYNJ), were not adjusted from Census reporting
- Revenue and expenditure estimates are divided by the total population, state personal income, or state GDP
- National averages are the U.S. total revenue or spending divided by U.S. total population, personal income, or GDP
  - Washington, D.C., revenues and expenditures are included in the national average, but Washington, D.C. is excluded from the state-level analysis
